### OVERVIEW

This website is operated by High Lane Cricket Club. Throughout the site, the terms “we”, “us” and “our” refer to High Lane Cricket Club. High Lane Cricket Club offers this website, including all information, tools and services available from this site to you, the user, conditioned upon your acceptance of all terms, conditions, policies and notices stated here.

Social membership is a non-voting membership which entitles members to use non-playing facilities including clubhouse, bar and car park. All club members accept the current code of conduct and club constitution at point of application as published on the club website.

Voting rights are given to 'Senior Cricket Players' and 'HLCC Committee Members' as defined on ECB 'Play cricket platform'.
