2. Chairman's Report (Chris Simpson)

2023 was a momentous year for the club as we saw the realisation of our 3-year vision both on and off the pitch. The club has now completed a 'bounce back from the brink' and stands ready for an exciting future.

Delivering on our promises to build a sustainable future

We have now completed a significant investment in the club infrastructure and established our Middlewood ground as one of the top venues in the league. Our Training facilities & Changing facilities are now complete and provide us with the capability to grow our cricket section in 2024. We have installed solar power and its already contributing to reducing the energy bills and environmental impact of our club with support from ECB.

In 2023, we focused on ensuring we delivered affordable cricket despite huge increases in running costs (e.g. ground maintenance). By planning for the future, we have transformed the sustainability of our club:

- Our social section continues to receive rave 5* reviews thanks to our dedicated team. We now have a full premises license and have bookings every week for months in advance.
- HLFC are firmly established with seven teams playing at some stage of season @ Middlewood. The partnership provides access to grants from Football Foundation which allowed us to secure our outfield equipment needs for cricket and football.
- Sponsorship has grown significantly with our fantastic local businesses supporting us through-out the season. Massive thanks to The Bulls Head and Blueberries as always!

2023 was the first year where we anticipated seeing the benefits of the growth in our club on the pitch ... and we were not disappointed!!

The addition of Kelly Jones to our 1st XI as Overseas player proved the right answer at the right time. Kelly took the league batting and bowling averages for Division 2 and the team were within a whisker of promotion. We now have three senior teams firmly established with our policy of supporting youth paying dividends.

We have reestablished a competitive junior section at all age groups and have steady flow of players emerging out of 'All stars'. We have numerous players actively engaged all year round in the Cheshire pathway for development with players under consideration at District level.

Thoughts for the future ...

Our new committee will be well placed to continue the great work of 2023. We already have established some key areas of focus agreed for 2024 with our existing committee:

- Updating our constitution to reflect how the club operates today to ensure criteria for membership are clearly agreed by committee and confirm voting guidelines
- Continuing the journey towards fully inclusive cricket: Launch of Women's & Over 40s team.
- Developing area 'Around the boundary' with projects including canal access, our scorebox, the environment and children's play area.
- League review: Consult in the summer to consider the options to support long-term development of cricket at HLCC.

We are always keen to welcome new faces both on and off the pitch. The future of the club is in our hands and we need to ensure we don't rely on a handful of key individuals as our club grows.

The club maintained a very healthy level of operating income thanks to maintaining 'Bar/food profit' (Over £19K).

The cash position at 31 October was £31,894.89 in Business Reserve Account and £8,761.05 in current account giving total cash balance of £40,655.94.

We are successfully diversifying income streams available e.g. Clubhouse hiring (£3.5K); Sponsorship (£1K). Our aim remains to ensure cricket remains affordable by constraining increase in subscription fees.

Our partnership with HLFC (£5K) helps to cover increased operational costs. Further opportunities exist to grow income on social side e.g. Club Events.

YE 2023 will be the final year of exceptional investment thanks to completion of major infrastructure projects (e.g. Changing rooms & Nets).

Increased operational costs (e.g. utilities, insurance, ground maintenance) continues to be a concern.

Our overseas player has proven a worthwhile investment on and off the pitch and will be continued in future years.

We continue to review ideas to run the club more efficiently and effectively (e.g. brewery deals) to ensure we sustain our growth and reduce financial risks

The club has invested significantly in the club infrastructure over the last three years to provide a platform for future growth. Whilst the club continues to maintain healthy reserves, the committee and trustees have agreed to draft a Reserves policy to govern future requests for drawdown to support projects to the long-term benefit and sustainability of our club.

5. 2024 Subscription policy (Dave Cheetham)

As a committee, we have a duty of care to treat all members equally and to share the financial burden of running the club both across the year and on match days. The club strives to reduce the burden to its players and parents through other commercial activities and keep subscriptions affordable whenever possible.

Annual Cricket Subscription

Contribution towards annual costs of facilities and ground @ Middlewood. Due to the cost of living crisis, we have decided not to increase subs from 2024.
